NEW VISA PROCESS FOR TOURISTS VISITING SRI LANKA

We the industry want to bring to your attention recent changes in the tourist visa process for visiting Sri Lanka. On April 16th, 2024, the Controller General of Immigration issued a notice suspending the Government ETA (Electronic Travel Authorization) website. Consequently, visas will now be processed exclusively through a private company-operated website at <u>https://www.srilankaevisa.lk/</u> starting April 17th, 2024.

We have raised our concerns with the Honorable Minister, who has assured us that a single-entry tourist visa will be made available for US\$ 50 inclusive of all charges by May 1st, 2024. However, the application process remains complex and unfriendly, with additional fees likely to apply.

There has been a significant increase in the cost of tourist visas, with the new private website not offering the previously available single-entry tourist visa with a 30-day validity. Instead, only a more expensive six-month multiple-entry visa is currently available at a total cost of US\$ 100.77 due to additional service and convenience fees.

A recent study indicates that Sri Lanka now has the highest visa costs in Asia, creating a significant barrier for tourists compared to competing destinations like Thailand, Vietnam and many other destinations that offer free visas or charge much lower fees. Moreover, as we go into the period of family travel in July & August, the current fees would require a family of four to pay US\$ 400 just to enter the country.

We have attached herewith a report with information on visa costs and how this change of process and cost increase will affect the industry in Sri Lanka. We have also attached an email sent out from the new visa website to a tourist, asking him to re schedule his holiday as they are unable to issue the visa in time, due to a glitch in the system.

The tourism industry, a key pillar of our economic recovery, is aiming for 2.3 to 2.5 million tourist arrivals in 2024. However, these visa changes threaten this goal. The abrupt fee increase and complicated process are likely to deter tourists, potentially reducing arrivals to below 2 million. We cannot therefore help but wonder your excellency, whilst yourself together with the tourism authorities and industry lead by the Honorable Minister, are working tirelessly to rebuild, that some elements, from within your government, are trying to disrupt the progress.

Issues & concerns with the high visa fees & the new system.

Issue with the Price Increase -

- Loosing competitiveness Sri Lanka now will have the highest Visa Fee of any of our direct competitors.
- Against the trends Sri Lanka's increase is out of step with regional competitors like China, Thailand, and Bhutan, who are either offering free visas or lowering costs.
- High Costs High additional service fees (approximately \$25) are very excessive for a process that was previously more efficient and locally managed. If 2 million Tourists area reached 50 million USD in additional fees will be charged.

Issue with the new system -

- **No Multi Language Functionality –** the bulk of the visitors to Sri Lanka have limited English.
- **Ease of use –** The previous system was straightforward and extremely easy to use for those with limited IT knowledge. The current system is complex with an OTP system, scrolling sections that are not easy to find, requirements of documents, complex format requirements for documents, unnecessary required fields (Second Address Line, Post Code) & asks for unnecessary details like Facebook, Twitter accounts.
- **Group Requests –** The previous system had a simple system to add multiple people to a request. Currently this system has a feature but requires you to reenter a lot of the information.
- **Security & Privacy–** The website lacks a clear privacy policy and does not seem to adhere to global data protection laws. The security of data must be evaluated further.
- **Bugs** Various users have reported down time on the site, bugs, unclear error messages and no confirmations.

Other Issues -

- **Communication** The launch and communication of the said launch have been poor making Tour Operators around the world panic. It is vital that all major changes and price increases be announced with enough lead time and clear communication on process in order not to damage the reputation of Sri Lanka.
- **Longer Visas** Creating longer stay visa's will further impact the current issue of foreigners illegally working in Sri Lanka. Further, attracting long-stay tourists may discourage traditional, shorter-term visitors, potentially reducing overall tourist spending and impacting the local tourism capacity as longer-stay tourists are always lower spenders and maybe travelling for other reasons than tourism.
